**ANNOUNCEMENT MADE IN ACCORDANCE WITH
RULE 13.18 OF THE LISTING RULES**

The directors (the “**Directors**”) of Yue Da Mining Holdings Limited (the “**Company**”) announce that on 28 October 2013, the Company, as borrower entered into a loan facility agreement (“**Facility Agreement**”) with a bank (the “**Bank**”), by which the Bank has agreed to grant to the Company a term loan facility to the extent of HK\$60 million. The facility is available for two months from 21 October 2013, being the date of the relevant facility letter. Subject to the terms of the Facility Agreement, the maturity date of the loan generally falls on one year from the first drawdown date of the loan or five business days before the expiry date of the standby letter of credit (“**SBLC**”) issued by the Bank, whichever is earlier, which may be extendable to two years from the first drawdown date, subject to (among other terms and conditions) the Bank’s satisfactory annual review and successful annual renewal of the SBLC.

Under the Facility Agreement, the Company has covenanted and undertaken to the Bank (among other terms and conditions) that at least 30% of its entire issued share capital will remain to be owned (directly or indirectly) by Jiangsu Yue Da Group Company Limited (江蘇悦達集團有限公司) (“**Jiangsu Yue Da**”). As at the date of this announcement, Jiangsu Yue Da is indirectly interested in approximately 42.51% of the issued share capital of the Company.
